


## **Adobe Shared Review Bullet List for Lead Designers**

- Make sure your pdf is ready for distribution. PSE plans require a cost estimate and a header.
  The cost estimate should be prepended to the pdf. The header should state PS&E date, time
  and page number. Draft environmental documents that contain decision documents –
  executive decisions require the adobe stamp for "Executive Decisions Page".
- 2. Copy the PS&E pdf to your local hard drive (example: desktop).
- 3. Create a folder under N:\~AdobeSharedReview\PSE\_Review\_by\_Bid\_Opening\[Bid Opening Date] or N:\~AdobeSharedReview\ Temp\_by\_Deadline\[Deadline\_Month].
- 4. Open the pdf and use the "Send for Shared Review" tool.
- 5. Select the "Automatically collect comments on my own internal Server" option.



6. Select the "Network folder" option and use the Browse button to the designated folder.









7. Select "Save a local copy and manually send it later". Save the local copy in the same folder used above. Use the Browse button to designated folder.

 Usually these setting for PS&E reviews won't be used twice because folder path for each PS&E should be unique. Therefore the name of this profile really isn't import.





9. Don't use Adobe for your email. Leave the "To" field empty. Click on "Review Deadline" to adjust the deadline for the PS&E Review. The deadline for all PS&E reviews shall be 5:00 pm on the first business working day before the PS&E Meeting.

10. Publish existing comments and stamps if prompted.



11. Use windows explore to confirm that the shared review document has been correctly posted. You should be able to open the review document and see the ribbon prompting you for comments by a specific deadline.




- 12. Manually set the file property to read only. Only the pdf file should be set to read only. The folder properties should be left alone.
- 13. Use Microsoft Outlook to setup the PS&E Meeting or email for draft environmental documents such as a documented categorical exclusion (DCE). All PS&E invitations should use the text on the second to the last page of this document as a template. All DCE invitations should use the text on the last page of this document. Copy the text and paste it in your email invitation.

14. If your receive coment from someone outside the NDDOT you will need to import these comments into the shared review process.



- 15. Attach other PS&E comment from users that didn't participate in the shared review process.
- 16. Conduct PS&E Review.
- 17. Respond to and Archive Comments.



- 18. Move archived comments and responses to the R drive project "eplans>ps\_e" folder.
- 19. Purge the shared review documents from the N drive.
- 20. Send a hyperlink of the archived document to whoever needs the comments and responses.
